The GIFT Nifty trends suggest a positive opening for the broader index in India, with a 0.55 percent gain or 123 points. The NSE has added Biocon, Granules India, India Cements, and LIC Housing Finance to the F&O ban list for May 16, while retaining Balrampur Chini Mills, Birlasoft, GMR Airports Infrastructure, Hindustan Copper, Vodafone Idea, Piramal Enterprises, SAIL, and Zee Entertainment Enterprises to the said list. Canara Bank was removed from the said list. FIIs sold shares worth Rs 2,832.83 crore. DIIs pumped in Rs 3,788.38 crore worth of stocks on May 15. The dollar index, which measures the US currency's strength against major currencies, was trading at 104.087, down 0.25 percent from its previous close of 104.34.
